**A RESOLUTION OF THE NEWVILLE BOROUGH COUNCIL,
CUMBERLAND COUNTY, PENNSYLVANIA
ENACTING A COMPREHENSIVE FEE SCHEDULE.**

WHEREAS, the Borough of Newville, pursuant to 53 P.S. 46202, has the authority to prescribe reasonable fees and charges; and

WHEREAS, the Newville Borough Council is desirous of enacting a comprehensive fee schedule which amends with respect to certain charges.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY ADOPTED by the Council of the Borough of Newville as follows;

SECTION 1: The preamble recited above is incorporated by reference herein.

SECTION 2: The following fees and charges are hereby imposed by the Borough of Newville:
