**AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF NEWVILLE,  
CUMBERLAND COUNTY, PENNSYLVANIA TO AMEND THE  
ZONING ORDINANCE OF THE BOROUGH OF NEWVILLE, CUMBERLAND  
COUNTY, PENNSYLVANIA, TO AMEND THE PROVISIONS RELATING  
TO PROHIBITED SIGNAGE IN ALL DISTRICTS**

WHEREAS, the Borough, pursuant to 53 P.S. 10601, Act of July 1, 1968, P.L. 805, as reenacted by Act of December 21, 1988, P.L. 1329, has the authority to enact and amend zoning ordinances.

WHEREAS, the Borough Council desires to amend the provisions of the Zoning Ordinance relating to prohibited signage in all districts.

NOW THEREFORE, BE IT ENACTED AND ORDAINED and it is hereby adopted by the Newville Borough Council as follows:

**ARTICLE IV – Supplementary Regulations Applying to All Districts**

**Section 4.5 – Supplementary Sign Regulations in all Districts:**

**Amend Section 4.5.4 to add the following to the list of prohibited signs:**

**4.5.4.9 Signs or displays visible from a lot line that exhibit statements, words, or pictures that are obscene or pornographic.**

This Amendment shall take effect five (5) days from enactment of this Ordinance.
